Rare Opportunity to Elect Three New Judges

This Nov. 3 General Election is a rare opportunity to elect three new judges to the state Supreme Court. It means we would have a majority vote in support of our issues for the first time. Your vote is extremely important, since many people do not know the importance of this election for our state and may not vote.

New Sexual Violence Protection Law

Pennsylvania has had a Protection from Abuse Law since 1976, allowing eviction and stay-away orders to be entered against intimate partners, family or household members as a result of physical abuse or threat thereof.

Now, effective July 1, 2015, is a new law called Protection of Victims of Sexual Violence or Intimidation Act. It extends civil remedies, whether or not criminally prosecuted, to unrelated parties involved in rape, sexual assault, or intimidation. It also calls for a statewide registry, training of law enforcement, penalties for non-compliance, emergency relief by minor judiciary, assistance of counselors, and confidentiality.

PA Supreme Court Suspends A. G. Kane

The Pennsylvania Supreme Court has suspended her as State Attorney General for the practice of law. Kane has been arrested for leaking confidential information from a grand jury investigation and is awaiting trial.

The state Supreme Court made it clear that Kane was not disbarred and that her suspension has no affect on her job. However, the Pennsylvania Constitution says the Attorney General must be a lawyer, and the Republican legislature may move to impeach her.
